HAWAIIAN SHORES COMMUNITY ASSOCIATION PARK OPERATING RULES

- 1. All members are required to present membership cards to HSCA personnel upon entry into facilities.
- 2. Children under the age of 14 must be accompanied by an adult to enter the park. Persons under the age of 18 are not allowed to bring in guests.
- 3. Guest fee will be \$2.00 per guest per day and paid at time of entry to recreational facilities.
- 4. Members with guests must accompany them and remain on the premises until all their guests have left. The number of guests per membership is limited to 5 per day.
- 5. Owners expecting more than 5 guests <u>must</u> make prior arrangements with the office. Owners may contact the office to reserve a pavilion for parties.
- 6. No illegal activity allowed on recreational facility property.
- 7. No riding of skateboards, rollerblades or bicycles in the park or in the parking lots.
- 8. No animals allowed in recreational facilities, except for service animals that are needed by disabled individuals using the park and restrooms.
- 9. Members and/or guests may be immediately removed from the facilities for any conduct that is deemed detrimental to other users or employees.
- 10. Proper footwear (non-marking soles) must be worn while on tennis courts.
- 11. The association is not responsible for personal belongings.
- 12. No smoking allowed on premises.

- 1. No lifeguard on duty SWIM AT YOUR OWN RISK!
- 2. CHILDREN UNDER THE AGE OF 14 MUST BE SUPERVISED BY AN ADULT IN THE POOL ENCLOSURE AT ALL TIMES. Persons under the age of 18 are not allowed to bring in quests.
- 3. ALL users are required to take a shower before entering pool.
- 4. Users are required to wear appropriate swimwear. Long hair must be braided or tied back. Children not potty trained must wear swim diapers.
- 5. No animals are allowed within the park or pool enclosure. Service animals may be allowed at the discretion of HSCA personnel.
- 6. No food or drink is allowed in pool enclosure with the exception of plastic bottles containing water.
- 7. Smoking is prohibited on the premises.
- 8. Pool users having an infectious or communicable disease/condition will be excluded from using pool.
- 9. Pool users having open cuts, blisters or sores are warned that these are likely to become infected and are advised not to use the pool and pool users with these conditions may be immediately removed from the pool at the discretion of HSCA personnel.
- 10. Use of pool toys (i.e. inflatable rings, loungers, etc.) are subject to HSCA personnel's discretion.
- 11. THE FOLLOWING CONDUCT IS PROHIBITED IN POOL AND POOL ENCLOSURE:

DIVING ABOVE POOL DECK ROUGH PLAY RUNNING SPITTING

SPOUTING OF WATER

NOSE BLOWING

FOUL OR ABUSIVE LANGUAGE

12. Members and/or guests failing to follow these rules or engaging in conduct deemed detrimental to other users or employees may be immediately removed from the pool enclosure and/or park.
