# **Updated Park and Pool Rules**

Pool rules: Members under the age of 18 cannot have guests. Children who are not potty trained need to wear swim diapers. No animals are allowed within the pool enclosure. Smoking is prohibited on all the premises. Pool users having an infectious or communicable disease/condition will be excluded from using pool. Pool users having open cuts, blisters or sores are warned that these are likely to become infected and are advised not to use the pool and pool users with these conditions may be immediately removed from the pool at the discretion of HSCA personnel

Park rules: All children under the age of 14 must be accompanied by an adult. Wrist bands are required for large parties. Service animals are allowed to accompany people to the park and the restroom.
