Approve Agenda

The Annual Meeting Agenda was previously mailed to the members. After review, the following motion was passed:

Dawn Hurwitz moved to adopt the 2021 Annual Membership Agenda. Nikki Weingartner seconded. Motion passed by unanimous approval.

Memberships' Approval of May 9, 2020 Meeting Minutes

Tom Cumming moved to adopt the May 9, 2020 Annual Membership Meeting Minutes, Jeffrey Kraybill seconded. Motion passed by unanimous approval.

Guest Speaker: Elena Cabatu, HMC

Hilo Medical Center Director of Marketing, Elena Cabatu provided up-to-date COVID 19 Vaccination information to the membership. The last mass vaccination clinic will be on May 15, 2021, shots will continue to be available at their clinic.

Guest Speaker: Ashley Kierkiewicz, County Council District 4

District 4 County Council Representative Ashley Kierkiewicz addressed members' concerns including roads, squatter homes, roundabout, trailers at transfer stations and illegal dumping.

President's Report - The President's report was previously mailed to the members. Water project almost completed, Honu Park and Swimming Pool remain open with COVID 19 restrictions, all roads were resurfaced and lot numbers were stenciled, HSCA bid aloha to Sheldon, retiring after 10 years, and welcomed Chaz to the maintenance crew.

Treasurer's Report - The treasurer's report was previously mailed to the members. The report was summarized for the membership by Barbara Barr, HSCA Accounting Associate.

Member Comments

Edley Rondinone – Commented about ruts on the side of the streets and how they might be avoided. Steve Bailey said they were mostly due to unusually wet weather and mail delivery. Dawn Hurwitz suggested moving mail boxes to the edge of the road so mail truck doesn't have to go off the pavement to deliver mail. Edley Rondinone also asked if there were any way to stop off road vehicles (ATV's) from operating on HSCA roads especially at night. Eileen O'Hara recommended a Neighborhood Watch group be started up again.

Jeffrey Kraybill – Commented about feral pigs in the area. Tom Cumming reported that there is a need for more pig traps, pigs are everywhere.
