Steve Bailey moved to approve the November 30, 2021 meeting minutes. Nikki Weingartner seconded. The motion passed unanimously. There was no discussion.

Old Business

The first item of old business concerns Lot 276; He'e St. - Vehicle has been removed.

Steve Bailey moved to waive the fines on Lot 276. Tom Cumming seconded. The motion passed unanimously.

The next item of old business concerns Lot 1533; O'opu St. - Bulldozer removed green waste and tree limbs.

The next item of new business concerns Lot 1479; Oio St. – Albizia and vine-covered trees threatening neighboring property. Work has been completed.

The next item of new business concerns Lot 1512; Ono St. – Owner will be taking care of the Albizia, requesting an extension. Will hold over to the next meeting.

Steve Bailey moved to fine the owner of Lot 1763 for encroaching vegetation. Nikki Weingartner seconded. The motion passed unanimously.

The last item of new business concerns coordination with Neighborhood Watch on Distressed/Vacant properties.

Action item: Steve Bailey will compile a list of the worst offending properties and forward it to the office staff and to committee members. Office staff will check the list for any properties that may be under foreclosure and if not committee members can consider referring them to the NHW process.
